Subject:- This Office advertisement notice No: RCD-886/Oct-2010/4621-50/DSMG dated 19/10/2010 & Re-advertisement Notice No:RCD-8864/4388-4408 dated 04/10/2012 regarding selection of Class-IV posts in the State Motor Garages Department.

Whereas; the Departmental Committee for recruitment to Class IV posts in the State Motor Garages Department constituted by the Government vide Order No:06-TR of 2016 dated 25/01/2016, recommended a selection list of 29 (Twenty Nine) candidates in different categories for class IV posts of Helper, Chowkidar, Cleaner and Safaiwalla;

Whereas, on the basis of overall merit viz. academic as well as interview points the selection list of 29 candidates for the post of Helper, Cleaner, Chowkidar and Safaiwala was notified by this office vide No:RCD-886/1395/DSMG dated 14.06.2017;

Whereas, out of 29 candidates of Class-IV, some candidates have not reported to this office notwithstanding the fact that selection list vide No:RCD-886/2017 dated 14.6.2017, Notice NO:RCD-886/2017 dated 5.7.2017 and Final notice NO:RCD-886/2017 dated 28.7.2017 were published in the leading Newspapers and also displayed on the official website viz. jksmg.gov.in;

Whereas, among others one incumbent namely Mohammad Shafit S/o Mohammad Azam R/o Dehri Ralyote Rajouri was selected as Helper under ST Category, but after issuing three notices to him, he conveyed his unwillingness to join in the State Motor Garages Department through an affidavit;

Whereas, consequent upon non-reporting of Mohammad Shafit S/o Muhammad Azam R/o Dehri Rajouri, the candidate figuring at serial No:1 in the waiting list of Helper under ST category viz. Mr. Shakir Karim S/o Abdul Karim Gujree R/o Safakadal Srinagar was asked vide two notices to report to this office alongwith original certificates, but he also failed to report within the stipulated time frame;

Whereas, after expiry of the date of final notice, the Helper posts under Schedule Tribe category became vacant due to non-joining of one Mr. Shakir Karim S/o Abdul Karim Gujree R/o Safakadal Srinagar;

Whereas, the vacant posts of Helper under ST category need to be filled up from the waiting list of Helper under ST Category;


Whereas; one Afaq Ahmed S/o Mushtaq Ahmed R/o Channi Mela Rajouri figuring at S.No.2 in the waiting list under ST Category of Helper, approached to this office for his appointment against the post of Helper vacated by Shri Shakir Karim, S/o Abdul Karim Gujree R/o Safakadal Srinagar;

Whereas, in terms of sub-rule (7) of Rule 14 of Jammu & Kashmir Civil Services Decentralization and Recruitment Rules, 2010 (SRO 375, dated: 21.01.2010) the vacancy caused to non-joining of Shri Shakir Karim, S/o Abdul Karim Gujree R/o Safakadal Srinaga against the post of Helper (ST Category) is a drop-out vacancy and accrues to the candidate figuring at S.No.2 in the waiting list in the relevant category;

Now, therefore, in light of the above facts and circumstances, sanction is hereby accorded to the temporary appointment of **Mr. Afaq Ahmed S/o Mushtaq Ahmed R/o Channi Mela Rajouri** as **Helper** under Schedule Tribe Category (State Cadre) in the Pay Band of Rs.4440-7440 + Grade Pay of Rs.1400/= in State Motor Garages Department.

The above appointment shall be subject to the following conditions that:-

1. The appointee shall be allowed to join only on furnishing an undertaking in the shape of an affidavit to the effect that in case an adverse report about his Character and Antecedents, Qualification, Date of Birth, Marks Certificate and State Subject Certificate, Category certificate, is received from the competent authority to whom the references shall be made by this office, the candidate shall have no right to claim his appointment as Helper and his appointment as such shall be deemed to have been cancelled ab-intio. He will not also claim for any dues from State Motor Garages Department as well in that case.
2. Certificate from the General Manager, District Industries Center and Deputy Director, District Employment & Counseling Center concerned to the effect that he has not taken any kind of loan from them under any scheme.
3. Salary of the appointee shall not be drawn and disbursed to him until and unless satisfactory report in respect of Point No. 1 above is received.
4. The appointee shall report in this office alongwith following documents in original within a period of 21 days from the date of issuance of this order, failing which the appointment shall be liable for cancellation without any further notice. The appointment is however, subject to the



verification of following documents/certificates from the concerned authorities to whom references shall be made by this office.

- i) Matriculation/ Date of Birth Certificate
 - ii) Marks Certificates.
 - iii) State Subject Certificate issued by the competent authority
 - iv) Certificate to the effect that the appointee has not taken any loan/financial assistance under any self employment scheme from DIC and District Employment and Counseling Centre concerned.
 - v) Health Certificate issued by the CMO Concerned
 - vi) Category Certificate
5. The appointee shall be on probation for a period of two years in first instance.
6. The above appointee shall be governed by the "New Pension Scheme" as notified vide SRO- 400 of 2009 dated 24/12/2009.

This appointment order is however, subject to the out come of writ petition, if any, pending before any Hon'ble Court of Law.

Consequent upon the above, the appointee shall report to Deputy Director State Motor Garages Department Jammu for further duties.
