Subject:-Compassionate Appointment under SRO-43 of 1994 in the SMG Department, J&K.

In pursuance of the approval conveyed by the Administrative Department vide letter No. TRPT-SMG0SRO/1/2021-02 dated 08.11.2023 followed by receipt of the satisfactory verification report from CID J&K vide Form No. 88970 dated 21.11.2023, sanction is hereby accorded to the appointment of **Mr. Vikas Kumar S/o Romesh Kumar (Ex-Black Smith) R/o H. No. 31-B Om Nagar Udheywala Jammu as Multitasking Staff (MTS) UT Cadre** in the State Motor Garages Department in the **Pay Level-SL1 (14800-47100)** in relaxation of rules (Qualification bar) on compassionate grounds under SRO-43 of 1994.

The appointee shall report to this office within a period of 21 days from the date of issuance of this order failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:-

- i) *Academic/Qualification Certificates.*
- ii) *Matriculation/Date of Birth Certificate.*
- iii) *Health Certificate from the concerned Chief Medical Officer of the District.*
- iv) *Domicile Certificate issued by the Competent Authority.*
- v) *Valid relevant Category Certificate, if any applicable.*

The appointment of the above candidate shall further be subject to the following conditions:-

- a) The appointee shall furnish an undertaking in the shape of an affidavit to the effect that in case an adverse report about his Qualification Certificate, Date of Birth Certificate, Domicile Certificate and Relevant Category Certificate is received from the Competent Authority to whom the references shall be made by this office, the candidate shall have no right to claim his appointment as **Multitasking Staff (MTS)** and his appointment as such shall be deemed to have been cancelled ab-initio and he will not claim for dues from the State Motor Garages Department as well in that case.
- b) That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an

affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- c) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory report in respect of genuineness of Qualification Certificate, Date of Birth Certificate, Domicile Certificate and Relevant Category Certificate is received from the concerned Authorities/Agency.
- d) The appointee shall be on probation for a period of two years.
- e) The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f) The inter-se-seniority of the appointee in the State Motor Garages Department shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- g) The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.

Consequent upon the above, the appointee is posted in Regional Office, State Motor Garages Department Jammu for further duties and the Departmental Employee Code No. 1233 is allotted to him for future references.
