Whereas, on the basis of overall merit i.e academic as well as interview points, the selection list of the candidates for the post of Helper, Cleaner, Chowkidar and Safaiwala was issued by this office vide No:RCD-886/1395/DSMG dated 14.06.2017;


Whereas, among others one incumbent namely Mohammad Shafit S/o Mohammad Azam R/o Dehri Ralyote Rajouri was selected as Helper under ST Category, but after issuing three notices to him, he conveyed his unwillingness to join in the State Motor Garages Department through an affidavit;

Whereas, consequent upon non- reporting of Mohammad Shafit S/o Muhammad Azam R/o Dehri Rajouri, the candidate figuring at serial No:1 in the waiting list of Helper under ST category viz. Mr. Shakir Karim S/o Abdul Karim Gujree R/o Safakadal Srinagar was asked vide two notices to report to this office alongwith original certificates, but he also failed to report within the stipulated time frame;

Whereas, as per the selection list issued by this office vide No:RCD-886/2017/DSMG dated 14.6.2017, you are figuring at serial No:2 in the waiting list for the post of Helper under ST category;


