
### AUCTION NOTICE

It is notified for the information of General Public that the State Motor Garages Department is conducting Open Public Auction of Condemned Vehicles/ Un-serviceable Stores etc of State Motor Garages Department, Other Government Departments and J&K Road Transport Corporation at the following places as per the schedule shown against each:-

#### **The Terms and Condition of the auction will be as under:-**

01. The auction will be conducted separately for each vehicle or lot thereof. The successful bidder in whose favour the bid finally closes upon its acceptance by Chairman Auction Committee, shall be required to deposit 1/4<sup>th</sup> of final bid amount on the spot immediately and remaining 3/4<sup>th</sup> within a period of 20 days alongwith GST as applicable under rules.
02. The SMG Department / J&KRTC shall forfeit 1/4<sup>th</sup> of the bid amount and security deposit of the successful bidder if he fails to deposit 3/4<sup>th</sup> of the bid amount including GST within a period of 20 days or does not lift the auctioned vehicle(s) or material within a period of one month from the date of acceptance of the bid as the case may be.
03. GST applicable under rules shall have to be paid extra by the successful bidder.
04. The Auctioned Vehicle(s) or Material shall be handed-over to the successful bidder by the Authorities of JKRTC / Deputy Director State Motor Garages Department Jammu as the case may be upon receipt of whole bid amount plus GST as applicable under rules.



05. The SMG Department / J&KRTC shall not be responsible for any damage caused to the Auctioned Vehicle(s) or Material occurring due to natural calamities, fire, theft etc.
06. The bidder desirous of participating in the auction proceedings, can inspect the vehicle(s) or Material at the notified locations which shall be available on the departmental website [www.jksmg.gov.in](http://www.jksmg.gov.in) before two or three days of the actual date of auction.
07. The Vehicle(s) and material, intended to be auctioned through Public Auction, is on '**as is where is**' basis and the SMG Department / J&KRTC shall presume that the interested bidder(s) have inspected the Vehicle(s) or Material and satisfied himself / themselves fully about the Vehicle(s) or Material which he/they intend to buy through Public Auction.
08. The interested bidder(s) shall have to deposit an amount of ₹20,000/= (Rupees Twenty thousand Only) with the SMG Department / J&KRTC before participating in the auction proceedings as the case may be. However, this amount will be refunded to the unsuccessful bidder(s) as soon as the auction proceeding are closed.
09. The bidders shall submit the GST certificate of firm at the time of depositing of security amount.
10. The Auction Committee reserves the right of accepting or rejecting any bid without assigning any reason thereof and the decision of the Chairman will be final.
11. Other terms and conditions, if any, will be announced on spot on the day of auction.
12. Entry of participants into the premises where auction is to be conducted shall be permitted only on production of verifiable RT-PCR or Rapid Antigen Test for Covid-19 not older than 72 hours and must carry a vaccination certificate with them and shall strictly follow social distancing, Covid Appropriate Behavior and SOPs of Covid-19.
