Subject:-Promotion of official appointed under Hon'ble Prime Minister's Package.

Whereas, the Department of Disaster Management, Relief, Rehabilitation & Reconstruction vide Government Order No. 58-DMRR&R of 2017 dated 29.07.2017 created five supernumerary posts of Mechanics in the State Motor Garages Department for return and rehabilitation of Kashmir Migrants under the Hon'ble Prime Minister's Package; and

Whereas, the Department of Disaster Management, Relief & Rehabilitation Reconstruction referred above five supernumerary posts of Mechanics to make selections amongst the candidates eligible interms of Jammu & Kashmir Migrants (Special Drive) Recruitment Rules notified vide SRO-412 of 2009 dated 30.12.2009 read with SRO-425 of 2017 dated 10.10.2017; and

Whereas, the Administrative Department (Transport Department) vide No. TR-9/SMG/2015 dated 15.05.2019 forwarded selection list of the candidate for the post of Mechanic in the State Motor Garages Department by the J&K Service Selection Board vide No. SSB/Secy/Sel/70/2019/2001-07 dated 19.03.2019 whereunder **Mr. Rakesh Bhat S/o Avtar Krishan Bhat R/o Delina Baramulla** has been selected as Mechanic Divisional Cadre Kashmir; and

Whereas, on the basis of selection made by the J&K Service Selection Board vide communication referred to above, **Mr. Rakesh Bhat S/o Avtar Krishan Bhat R/o Delina Baramulla** appointed in this Department as Mechanic against supernumerary post Divisional Cadre Kashmir in the Pay Level-6 (35400-112400) against OM category; and

Whereas, **Mr. Rakesh Bhat S/o Avtar Krishan Bhat R/o Delina Baramulla** joined in the State Motor Garages Department on 29.05.2019 against the post of Mechanic; and

Whereas, the Department of Disaster Management, Relief, Rehabilitation & Reconstruction vide Government Order No. 34-JK(DMRRR) of 2022 dated 22.06.2022 accorded sanction for maintenance of separate seniority list of the candidates appointed under Hon'ble PM Package by the appointing Department which shall run parallel to the seniority of regular employees in the appointing Departments and shall take effect from the date of appointment against these posts; and

Whereas, the State Motor Garages Department accordingly issued tentative seniority list vide No. RCD-939/1588-93/DSMG dated 22.06.2022 of the employees appointed in the State Motor Garages Department under Hon'ble PM Package as on 01.01.2022 and circulated for information of all concerned for inviting objections if any, with regard to tentative seniority list by or before 28.06.2022 followed by final seniority list issued vide No. RCD-939/1751-56/DSMG dated 29.06.2022;

Whereas, the Department of Disaster Management, Relief, Rehabilitation & Reconstruction vide Government Order No. 34-JK(DMRRR) of 2022 dated 22.06.2022 accorded sanction to the creation of pre-facto supernumerary posts at the corresponding higher level for the appointing Departments for career progression of employees appointed under PM Package by way of reducing supernumerary post at lower level. These supernumerary posts shall be specific to the employees concerned and shall be deemed to have been upgraded in personal capacity as and when these employees get promoted as per the eligibility criteria and in proportion to the regular employees. The promotion thus made will have to be based on seniority and eligibility as per recruitment rules and also creation of supernumerary posts in proportion to the existing ratio for the said posts given in the recruitment rules of the Department category wise.

Whereas, the above said official has completed three years service on 28.05.2022 and is found eligible for promotion to the post of Foreman as per the Recruitment Rules of the Department.

Therefore, as approved by the Departmental Promotion Committee in its meeting held on 05.07.2022, sanction is hereby accorded to the promotion of **Mr. Rakesh Bhat, Mechanic Employee Code No. 1200 (Supernumerary Post) to the supernumerary post of Foreman** in the **Pay Level-6D (35800-113200) w.e.f. 05.07.2022** by reduction of supernumerary post of Mechanic presently occupied by the said official.

The promotion of the official is however, subject to outcome of writ petition(s) if any pending before any Hon'ble Court of Law.
