### Terms and Conditions for e-Auction of Condemned Vehicles / Un-serviceable Stores.

1. The interested bidders shall have to deposit an amount of ₹ 10000/= (*Rupees Ten Thousand Only*) in the shape of CDR / FDR only pledged to the **Deputy Director, State Motor Garages Department Kashmir** as a security deposit within the period mentioned in the e-Auction Notice and submit the same in original to the Directorate of State Motor Garages Department J&K Srinagar / Jammu before participating in the Auction proceedings.
2. The CDR / FDR, however shall be released to the unsuccessful bidder(s) as soon as the Auction proceedings are closed and to the successful bidders after the fulfillment of all the following conditions:-
  - a) The successful bidder(s) shall lift the auctioned vehicle(s) / material after depositing full payment including GST / other taxes as applicable under rules in the office of **Deputy Director State Motor Garages Department Kashmir**.
  - b) The successful bidder(s) shall submit scrap certificate in the office of **Deputy Director State Motor Garages Department Kashmir** to the effect that the auctioned vehicle(s) has been scraped by him / them in presence of the representative of this Department in respect of vehicle whose life be neither extended nor transferable as per the Motor Vehicles Act / Rules.
  - c) The successful bidder(s) shall submit copy of new registration certificate in favour of the successful bidder issued by the concerned registering authority in the office of **Deputy Director State Motor Garages Department Kashmir** in respect of vehicle which is transferable as per the Motor Vehicles Act / Rules **OR** shall submit scrap certificate as per S. No. b) above, as the case maybe.
3. The successful bidder shall have to deposit 1/4<sup>th</sup> of the final bid amount within 03 days and remaining 3/4<sup>th</sup> amount including GST / other taxes as applicable under rules & shall lift the auctioned vehicles / material within 10 days from the date of acceptance of the bid on the GeM Portal.
4. In case the successful bidder fails to deposit the full payment including GST / other taxes as applicable under rules or fails to lift the auctioned vehicles / material within the stipulated period, the 1/4<sup>th</sup> amount and security deposit shall be forfeited without giving any reason / notice.
5. GST / any other taxes applicable under rules shall have to be paid extra over the final bid amount by the successful bidder.
6. The Auctioned Vehicles / material shall be handed over to the successful bidder by the **Deputy Director, State Motor Garages Department Kashmir** upon receipt of full payment including GST / other taxes as applicable under rules.
7. The State Motor Garages Department shall not be responsible for any damage caused to the Auctioned Vehicle(s) or Material occurring due to natural calamities, fire, theft, etc.
8. The bidders desirous to participate in the Forward Auction on the GeM Portal (e-Auction) can inspect the vehicle(s) or Material at the notified locations.
