

Whereas, **Mr. Asif Ali Bhat** who was appointed among others as Greaser Washer in this Department vide this office Order No. 301-DSMG of 2018 dated 27.06.2018 has failed to join in this Department besides he removed from the Selection List to Waiting List under OM Category as per the revised selection list issued by the J&K Service Selection Board and his appointment order as Greaser Washer in this Department is liable for cancellation ab-intio.
