As recommended by the J&K Service Selection Board vide communication referred to above and approval for appointment in the State Motor Garages Department conveyed by the Administrative Department vide No. TR-9/SMG/2015 dated 22.06.2018, sanction is hereby accorded to the temporary appointment of below mentioned candidates as Greaser Washer (State Cadre) in the State Motor Garages Department in the Pay Structure (19900-63200) Level-2 in the Pay Matrix.

The appointees shall be initially on probation for a period of five years and the fixation of pay & other service benefits shall be regulated strictly in accordance with the SRO-202 dated 30.06.2015.

The appointment of the above candidates shall be subject to the condition that:-

- 1) The appointees shall be allowed to join only on furnishing of an undertaking in the shape of an affidavit to the effect that in case an adverse report about their Character and Antecedents, Qualification, Date of Birth, Marks Certificate, State Subject Certificate, Category Certificate is received from the Competent Authority to whom the references shall be made by this Office, the candidate shall have no right to claim his appointment as Greaser Washer and his appointment as such shall be deemed to have been cancelled ab-initio and he will not claim for dues from State Motor Garages Department as well in that case.
- 2) Salary of the Appointees shall not be drawn and disbursed until and unless satisfactory report in respect of Point No. 1 above is received.



3) The appointees shall report to this office alongwith the following documents in original within a period of 21 days from the date of issue of this order failing which the appointment shall be liable for cancellation without any further notice:-

- a) Date of Birth Certificate.
- b) Qualification Certificate.
- c) Marks Certificate.
- d) State Subject Certificate.
- e) Category Certificate.
- f) Character Verification Roll (in triplicate) duly filled in.
- g) Certificate to the effect that the appointee has not taken any loan/Financial assistance under any self employment scheme from DIC and Employment & Counseling Department.
- h) Health Certificate of concerned Chief Medical Officer.

4) The appointment is further subject to the verification of above documents/ certificates from the concerned authorities to whom references shall be made by this office.

5) In case an adverse report about their Character and antecedents, Qualification, Date of Birth, Marks Certificate, State Subject Certificate, Category Certificate is received from the Competent Authority to whom the references shall be made by this Office, the candidate shall have no right to claim his appointment as Greaser Washer and his appointment as such shall be deemed to have been cancelled ab-intio and will not be entitled to any claim of dues from State Motor Garages Department as well in that case.

6) The Appointees shall be governed under **"New Pension Scheme"** notified by the Government under SRO-400 of 2009 dated 24.12.2009.

The appointment of the candidates is however, subject to outcome of writ petition(s) if any pending before any Hon'ble Court of Law.

Consequent upon the above, the appointees figuring at S. No. 01, 02 & 03 are posted in District Garages Depot Pulwama, Baramulla & Kupwara respectively for further duties.
