The tenderer shall have to upload scan copy of all below mentioned technical documents including Earnest Money Deposit (EMD) CDR/FDR/TDR for an amount of Rs.6.00 Lacs pledged to Accounts Officer, State Motor Garages Department J&K in the Portal of JK Tenders. The below mentioned original tender document shall be obtained only from the bidder who declared as L1 after opening of Financial Bid of **"Motorized Tricycle (Gear Less Scooter with Retro Fitted Side Wheels Attachment Suitable for Specially Abled Persons)"**.

Technical Bid document:-

- Earnest Money Deposit (EMD) CDR/FDR/TDR for an amount of Rs.6.00 Lacs pledged to Accounts Officer, State Motor Garages Department, J&K.
- Tax clearance certificate form Income Tax Department for last two assessment years/ 6 assessment quarters.
- An undertaking to the effect that the rates offered as well as validity of tender if approved by the Purchase Committee shall remain in force for one year from the date of execution of agreement.
- Copy of certificate if registered as an Start-up. SSI unit holders shall furnish the CDR/FDR/TDR as required under rules.
- The bidder has to provide specification with technical details of the Motorized Two Wheeler (Gear Less) with Retro Fitment along with test report certificate issued by any one of the testing agency by the Central Government under Rule 126 of Central Motor Vehicle Rules 1989.
- TIN number if any.
- Name and address of the firm (address of the Head Office and local branch office.
- Copy of PAN CARD.
- Goods and Service Tax Registration Certificate.

- j) List of Service Centers available in UT of J&K with contact numbers.
- k) Copy of authorization certificate in case of authorized dealer/distributor from Original Equipment Manufacturer (OEM).
- l) GST Return certificate latest.
- m) Applicable GST on the **"Motorized Tricycle (Gear Less Scooter with Retro Fitted Side Wheels Attachment Suitable for Specially Abled Persons)"** shall be Specified by the bidder in the Technical Bid.

Financial Bid:-


The "Financial Bid" is required to be uploaded on line as per the Bill of Quantities (BOQ) of this e-NIT.

Other Terms and Conditions of e-tender:-

- 1) In case of any breach of the agreement at any time on the part of the tenderer, the agreement shall be terminated summarily by the Department and a penalty of 2% of the total cost of ordered **"Motorized Tricycle (Gear Less Scooter with Retro Fitted Side Wheels Attachment Suitable for Specially Abled Persons)"** shall be imposed on the supplier and CDR/FDR shall be forfeited.
- 2) Disputes if any shall be settled by the Courts within the jurisdiction of J&K UT (Srinagar/Jammu).
- 3) No tender will be considered unless and until all the documents are properly signed.
- 4) During the period of contract if the price of the ordered **"Motorized Tricycle (Gear Less Scooter with Retro Fitted Side Wheels Attachment Suitable for Specially Abled Persons)"** decrease during the period of delivery the decreased price shall be considered as final.
- 5) Financial bid of only those tenderer shall be opened who will qualify the technical bid.
- 6) The successful bidder has to supply the **"Motorized Tricycle (Gear Less with Retro Fitted Side Wheels Attachment Suitable for Specially Abled Persons)"** as per the specifications of the supply order and technical expert nominated by Deputy Director, State Motor Garages Department; Jammu/Kashmir shall be final to accept the deliveries of after Pre-Delivery Inspection done.
- 7) The Department shall be at liberty to procure in minimum quantity as per requirement within 4-6 weeks (including holidays). In case of exigency the successful bidder (L1) shall be supplied within the shortest possible time failing which the Department shall approach L-2 bidder after obtaining non-availability certificate from L-1 bidder and on L1 rates.
- 8) Warranty period of **"Motorized Tricycle (Gear Less with Retro Fitted Side Wheels Attachment Suitable for Specially Abled Persons)"** at least five (5) years from the **date of delivery**, in case of detection of any defect during the said period the items shall have to be replaced free of cost by the successful tenderer.
- 9) **Rates shall be quoted FOR destination i.e. all District Head Quarters of J&K UT and should be inclusive of all taxes, Registration, Life Time Road Tax and Insurance:01 Year OD (Own Damage), 05 Year TP (Third Party) and 01 Year PA (Personal Accident) with Retro fitment. However, any tax variation shall be applicable at the time of delivery of "Motorized Tricycle (Gear Less Scooter with Retro Fitted Side Wheels Attachment Suitable for Specially Abled Persons)"** No interest shall be paid on

CDR/FDR and the FDR/CDR of the successful tenderer shall be converted into security deposit and those of unsuccessful tenderer shall be returned immediately after completion of the tendering process.

- 10) Any postal delay shall not be responsibility of the Department.
- 11) No terms and conditions of the tenderer shall be entertained by the Department.
- 13) The successful tenderer has to sign the contract on terms and conditions of this notice.
- 14) The Purchase Committee can stop the process at any time and can exercise options whatsoever, in the interest of the Government.
- 15) Purchase Committee reserves the right to accept or reject any tender at any time without assigning any reason thereof.
- 16) The bidder has to provide specification with technical details of the **"Motorized Tricycle (Gear Less with Retro Fitted Side Wheels Attachment Suitable for Specially Abled Persons)"** along-with test report certificates issued by any one of the testing agency by the Central Government under Rule 126 of Central Motor Vehicle Rules.
- 17) Delivery should be made within 45-60 days from the date of receipt of purchase order.
