The tenderer shall have to upload scanned copies of all necessary documents like CDR/FDR, Startups, Micro & Small Enterprises unit certificate, Pan card, GST No and Tax clearance certificate of last two years. The original tender document/ technical bid shall be submitted in a single sealed envelop superscribed as "Tender for supply of **"Paint Booth"** and **"Portable Pressure Car washer"** .

Technical Bid:

Technical bid duly sealed in an envelope shall contain the following:-

- CDR/FDR for an amount of Rs.35000/- pledged to Accounts Officer State Motor Garages Department J&K Government.

Copy of certificate if registered as an Startups, Micro & Small Enterprises unit. Startups, Micro & Small Enterprises unit holders shall furnish the CDR/FDR as applicable under rules.

d/ GST No/TIN number as applicable.

e/ Detailed catalogue of the machines given above be sent to the Directorate of SMG Bemina Bye Pass Road Srinagar.





The "Financial Bid" is required to be uploaded on line as per the Bill of Quantities (BOQ) of e-NIT.

Other Terms & Conditions of Tender:-

- 1) The hard copy of tender document should be properly sealed in the envelope and duly marked as tender for **supply of "Paint Booth" and "Portable Pressure Car washer"** addressed to Directorate State Motor Garages Department Bemina Bye Pass Road Srinagar.
- 2) The successful tenderer shall have to execute an agreement with the department within 7 days from the date of issuance of supply order as per the standard agreement form of Jammu and Kashmir Government. The firm shall also send attested copy of the supply order with the agreement to the Directorate of State Motor Garages Department J&K, with stamp duty of Rs.100/-.
- 3) The rates quoted will be valid upto one year from the date of placement of supply order.
- 4) The successful tenderer shall be responsible for installation/commissioning of the above machines at the sites to be identified by the Department. The testing and training to the concerned staff shall also be the responsibility of the successful tenderer without any charge.
- 5) *Guarantee/Warranty period of "Paint Booth" and "Portable Pressure Car washer" be specified with details of service station available in J&K State and in case of any defect is detected during the said period the item (s) shall have to be replaced free of cost by the successful tenderer.*
- 6) **Rates shall be quoted FOR Jammu/Srinagar and should be inclusive of all taxes.**
- 7) In case of breach of whole or any part of the agreement at any time from the successful tenderer, the agreement shall be terminated summarily by the Department and a penalty of 2% of the total cost of ordered **"Paint Booth" and "Portable Pressure Car washer"** shall be imposed on the supplier and CDR/FDR shall be forfeited.
- 8) Disputes if any, shall be settled by the Courts within the jurisdiction of J&K State (Srinagar/Jammu).
- 9) No tender will be considered unless and until all the documents are properly signed.
- 10) **During the period of contract if the price of the material of the ordered item (s) decreases during the period of delivery the decreased price shall be considered as final.**
- 11) Financial bid of only those tenderer (s) shall be opened who will qualify the technical bid.

- 12) In case the first successful tenderer fails to supply the ordered material within the prescribed time the same shall be procured from the 11nd lowest tenderer and difference cost shall be deducted from the First successful tenderer.
- 13) A certificate from the manufacturer of the above machines certifying the distributorship should be enclosed with the tender documents in case the tenderer happens to be distributor of the manufacturer for above machines.
- 14) Any postal delay shall not be responsibility of the department.
- 15) No terms and conditions of the tenderer shall be entertained by the Department.
- 16) Chairman, State Level Purchase Committee reserves the right to accept or reject any tender at any time without assigning any reason thereof.
- 17) The successful tenderer shall have to execute the supplies within the time limit specified in the supply order, in case of failure, CDR/FDR shall stand forfeited and the supply order shall also stand cancelled.
- 18) 100% payment shall be released after receipt of material/items duly verified by the inspection committee.


