For and on behalf of the Lt. Governor of J&K Union Territory e-tenders are invited from the manufacturers/Authorized Dealers/Distributors/Registered firms & suppliers for supply of **"Derby Shoes" Assorted Sizes** as per detail mentioned in Bill of Quantity (BOQ).

The tenderer shall have to upload scan copy of below mentioned technical documents including CDR/FDR in the portal of jk-tenders. The below mentioned original tender documents shall be obtained only from the bidder who declared as L1 after opening of financial bid of **"Derby Shoes"**.

Technical Documents:

- CDR/FDR for an amount of **Rs.30000.00** pledged to **Accounts Officer, State Motor Garages Department, J&K Government.**
- Tax Clearance Certificate from Income Tax Department for last 8 assessment quarters.
- An undertaking to the effect that the rates offered if approved by the State Level Purchase Committee shall remain in force for one 12 months from the date of approval of SLPC for procurement.
- Copy of certificate if registered as an Start-up (SSI unit holders) & CDR/FDR as required under rules
- GST Certificate.

Financial Bid:

The **"Financial Bid"** is required to be uploaded online as per the Bill of Quantities (BOQ) of e-NIT.

Other Terms & Conditions of Tender:-

- In case of any breach of the agreement at any time on the part of the tenderer, the agreement shall be terminated summarily by the Department and a penalty of 2% of the total cost of ordered item (s) shall be imposed on the supplier and CDR/FDR shall be forfeited.
- All tenderes shall submit their **samples of Derby Shoes before date of opening of Technical bid viz 25.1.2020.**
- Disputes if any, shall be settled by the Courts within the jurisdiction of Union Territory (Srinagar/Jammu).
- No tender will be considered unless and until all the documents are properly signed.

- 5) During the period of contract if the price of the ordered model decreases during the period of delivery the decreased price shall be considered as final.
- 6) Delivery of item (s) is further subject to the inspection by the inspecting authority to be nominated by the Director, State Motor Garages Department, J&K Government and no payment shall be released without the inspection certificate by the nominated team in token of that the supplies are as per approved samples by the State Level Purchase Committee.
- 7) Financial bid of only those tenderers shall be opened who will qualify the technical bid.
- 8) The Department shall be at liberty to procure the Derby Shoes in minimum quantity as per requirement within 12 days (including holidays). In case of exigency the item shall be supplied within the shortest possible time failing which the Department shall approach L-2 bidder after obtaining non-availability certificate from L-1 bidder.
- 9) *Guarantee/Warranty period of item (s) wherever applicable be specified and for such item, in case of detection of any defect during the said period the items shall have to be replaced free of cost by the successful tenderer.*
- 10) **Rates shall be quoted FOR destination i.e. Jammu/Srinagar and should be inclusive of all taxes,**
- 11) No interest shall be paid on CDR/FDR and the FDR/CDR of the successful tenderer shall be converted into security deposit and those of unsuccessful tenderer the same shall be returned immediately after completion of the tendering process.
- 12) Any postal delay shall not be responsibility of the department.
- 13) No terms and conditions of the tenderer shall be entertained by the Department.
- 14) The Chairman State Level Purchase Committee can stop the process at any time and can exercise options whatsoever, in the interest of the administration of the State Motor Garages Department.
- 15) Chairman, State Level Purchase Committee reserves the right to accept or reject any tender at any time without assigning any reason thereof.
- 16) The successful tenderer has to sign the contract on terms and conditions of this notice.
- 17) **Successful Supplier should have available stocks of assorted sizes both at Jammu and Srinagar to meet out the requirement of Shoes.**
- 18) 100% payment shall be made after receipt of verified bills of the ordered items from the consignee.
