**Subject:-** This Office advertisement notice No: RCD-886/Oct-2010/4621-50/DSMG dated 19/10/2010 & re-advertisement Notice No;RCD-8864/4388-4408 dated 04/10/2012 regarding selection of Class-IV posts in the State Motor Garages Department.

Whereas; the Departmental Committee for recruitment to Class IV posts in the State Motor Garages Department constituted by the Government vide Order No:06-TR of 2016 dated 25/01/2016, recommended a selection list of 29 (Twenty Nine) candidates in different categories for class IV posts of Helper, Chowkidar, Cleaner and Safiwalla;

Whereas; the said select list was published in the leading newspapers of J&K State through Information Department J&K vide this office No. RD-886/1839/DSMG dated 05/07/2017;

Whereas; one Mashooq Ahmad Lone S/O Lassi Mohammed Lone R/o, Chatripora, Mohalla, Kulgam was selected by the Departmental Committee for recruitment to Class IV posts in the State Motor Garages Department against two posts i.e for the post of Cleaner and Chowkidar under RBA category;

Whereas; the said Mashooq Ahmad Lone opted for the post of Chowkidar and submitted an affidavit duly attested by 1<sup>st</sup> Class Magistrate in this regard, wherein he has deposed that he shall have no claim for the post of Cleaner after appointment as Chowkidar in the SMG, Department;

Whereas; alongwith the main selection list, the Departmental Committee for recruitment to Class IV posts in the State Motor Garages Department had also recommended a waiting panel of 15 (fifteen) candidates in different categories for class IV posts of Helper, Chowkidar, Cleaner and Safiwalla;

Whereas; due to non- joining of Shri Mashooq Ahmad Lone against the post of Cleaner, one Cleaner post became available under RBA Category;

Whereas; one Shri Mohammad Aslam Raina S/o Ali Mohammed Raina R/o Kralwari, Budgam figuring at S.No. 1 in the waiting list under RBA Category of Cleaner list, approached to this office for his appointment against the post of Cleaner vacated by Shri Mashooq Ahmad Lone consequent upon his appointment against the post of Chowkidar;




Whereas, in terms of sub-rule(7) of Rule 14 of Jammu & Kashmir Civil Services Decentralization and Recruitment Rules,2010 ( SRO 375, dated: 21.01.2010) the vacancy caused to non-joining of Shri Mashooq Ahmad Lone against the post of Cleaner is a drop-out vacancy and accrues to the candidate figuring at S.No.1 in the waiting list in the relevant category;

Now, therefore, in light of the above facts and circumstances, sanction is hereby accorded to the temporary appointment of **Mr. Mohammad Aslam Raina S/o Ali Mohammad Raina R/o Kralawari, Budgam** as **Cleaner** under RBA Category (State Cadre) in the Pay Band of Rs.4440-7440 + Grade Pay of Rs.1400/= in State Motor Garages Department.

**The above appointment shall be subject to the following conditions that:-**


1. The appointee shall be allowed to join only on furnishing an undertaking in the shape of an affidavit to the effect that in case an adverse report about his Character and Antecedents, Qualification, Date of Birth, Marks Certificate and State Subject Certificate, Category if any, is received from the competent authority to whom the references shall be made by this office, the candidate shall have no right to claim his appointment as Cleaner and his appointment as such shall be deemed to have been cancelled ab-intio. He will not also claim for any dues from State Motor Garages Department as well in that case.
2. Certificate from the General Manager, District Industries Center and Deputy Director, District Employment & Counseling Center concerned to the effect that he has not taken any kind of loan from them under any scheme.
3. Salary of the appointee shall not be drawn and disbursed to him until and unless satisfactory report in respect of Point No. 1 above is received.
4. The appointee shall report in this office alongwith following documents in original within a period of 21 days from the date of issuance of this order, failing which the appointment shall be liable for cancellation without any further notice. The appointment is however, subject to the verification of following documents/certificates from the concerned authorities to whom references shall be made by this office.
  - i) Matriculation/ Date of Birth Certificate
  - ii) Marks Certificates.
  - iii) State Subject Certificate issued by the competent authority
  - iv) Certificate to the effect that the appointee has not taken any loan/financial assistance under any self employment scheme from DIC and District Employment and Counseling Centre concerned.
  - v) Health Certificate issued by the CMO Concerned



5. The appointee shall be on probation for a period of two years in first instance.
6. The above appointee shall be governed by the "New Pension Scheme" as notified vide SRO- 400 of 2009 dated 24/12/2009.

**This appointment order is however, subject to the out come of writ petition, if any, pending before any Hon'ble Court of Law.**

Consequent upon the above, the appointee shall report to Deputy Director State Motor Garages Department Kashmir for further duties.
