#### The Terms and Condition of the auction will be as under:-

01. The auction will be conducted separately for each vehicle or lot thereof. The successful bidder in whose favour the bid finally closes upon its acceptance by Chairman Auction Committee, shall be required to deposit 1/4<sup>th</sup> of final bid amount on the spot immediately and remaining 3/4<sup>th</sup> within 07 days.
02. The Corporation/Department shall forfeit 1/4<sup>th</sup> of the bid amount of the successful bidder if he fails to deposit 3/4<sup>th</sup> of the bid amount within 07 days or does not lift the auctioned vehicle(s) or material within 15 days from the date of acceptance of the bid.

03. Sales Tax or any other Tax, as applicable under rules shall have to be paid extra by the successful bidder.
04. The Auctioned Vehicle(s) or Material shall be handed-over to the successful bidder by the Authorities of JKSTRC / Deputy Director State Motor Garages Department as the case may be upon receipt of whole bid amount and Tax Clearance Certificate from the Commercial Taxes Department regarding payment of all Taxes.
05. The Corporation / Department shall not be responsible for any damage caused to the Auctioned Vehicle(s) or Material occurring due to natural calamities, fire, theft etc. in the premises of the Corporation / Department.
06. The bidder desirous of participating in the auction proceedings, can inspect the Vehicle(s) or Material in the premises of JKSTRC / SMG or at the place(s) where the vehicle(s) / Material are kept, two or three days ahead of the actual date of auction.
07. The Vehicle(s) and material, intended to be auctioned through Public Auction, is on 'as is where is' basis and the Corporation / Department shall presume that the interested bidder(s) have inspected the Vehicle(s) or Material and satisfied himself / themselves fully about the Vehicle(s) or Material which he/they intend to buy through Public Auction.
08. The interested bidder(s) shall have to deposit an amount of ₹5,000/= (Rupees Five Thousand Only) with the Corporation / Department before participating in the auction proceedings. However, this amount will be refunded back as soon as the auction proceeding are closed.
09. The Auction Committee reserves the right of accepting or rejecting any bid without assigning any reason thereof and the decision of the Chairman will be final.
10. Other terms and conditions, if any, will be announced on spot on the day of auction.
