Now, (05) candidates as detailed in the Annexure to this notification are advised through the medium of this **Final Notice** to report to this Directorate within a period of 10 days from the date of issue of this notice, failing which it shall be presumed that they are not interested to join in this deptt. against the post (He)/(They) have been selected and their selection shall be deemed to have been canceled forthwith without any further notice and the candidates next in merit in the waiting list shall be considered for appointment against the relevant post.
