Terms & Conditions of the tender

The tenders shall have to be submitted in a single sealed envelope containing two separate sealed envelopes superscribed as "Technical Bid" and "Financial Bid"

01. The technical bid duly sealed in an envelope shall contain the following:-
- CDR/FDR for an amount of Rs.5000/- pledged to Accounts Officer, State Motor Garages Department, J&K Government. The successful tenderer has to sign the contract on terms and conditions of the contract referred to in the tender form **Annexure "B"** to this notice.
 - Tax Clearance Certificate from Income Tax Department for last two assessment years.
 - The TVS Wego with attachment shall be procured as per the requirement of the Department.
 - An undertaking to the effect that the rates offered if approved by the State Level Purchase Committee shall remain in force for six months from the date of execution of agreement.
 - Copy of certificate if registered as an SSI unit.
 - Trade Certificate
 - TIN number if any.

02. The "Financial Bid" duly sealed in an another envelope shall contain following:-


- a) Rates quoted both in figures as well as in words against each vehicle(s) without any cutting or overwriting.
- b) Guarantee/Warranty period of TVS Wego with attachment wherever applicable be specified and for such Tricycle, in case of detection of any defect during the said period the items shall have to be replaced free of cost by the successful tenderer.
- c) Rates shall be quoted FOR destination i.e. Jammu/Srinagar and should be inclusive of all taxes and temporary registration number.
- d) Discount if any shall also be mentioned by the tenderer while quoted the rates.

Other Terms & Conditions of Tender:-

- 1) In case of any breach of the agreement at any time on the part of the tenderer, the agreement shall be terminated summarily by the Department and a penalty of 2% of the total cost of ordered TVS Wego with attachment (s) shall be imposed on the supplier and CDR/FDR shall be forfeited.
- 2) The successful tenderer will supply TVS Wego with attachment to the State Motor Garages Department, J&K only according to the description of the vehicles fixed by the vehicle manufacturer.
- 3) Disputes if any, shall be settled by the Courts within the jurisdiction of J&K State (Srinagar/Jammu).
- 4) No tender will be considered unless and until all the documents are properly signed.
- 5) During the period of contract if the price of the ordered model decreases during the period of delivery the decreased price shall be considered as final.
- 6) Delivery of TVS Wego with attachment (s) is further subject to the inspection by the inspecting authority nominated by the Director, State Motor Garages Department, J&K Government whose decision regarding the delivery shall be final and binding to consignees/indenting authority.
- 7) Financial bid of only those tenderers shall be opened who will qualify the technical bid.
- 8) No interest shall be paid on CDR/FDR and the FDR/CDR of the successful tenderer shall be converted into security deposit and those of unsuccessful tenderer the same shall returned immediately after completion of the tendering process.
- 9) No terms and conditions of the tenderer shall be entertained by the Department.
- 10) The vehicle(s) should be ARI certified and approved by State Transport Authority J&K (Motor Vehicle Department).
- 11) Chairman, State Level Purchase Committee reserves the right to accept or reject any tender at any time without assigning any reason thereof.
- 12) The Chairman State Level Purchase Committee can stop the process at any time and can exercise options whatsoever, in the interest of the administration of the State Motor Garages Department.


