For and on behalf of the Governor of J&K State, sealed Tenders affixed with Rs. 5/- Revenue Stamp are invited from the registered/reputed firms/dealers dealing in "Rewinding of Electric Motors" on yearly contract basis installed in Regional Workshop, State Motor Garages Department, Jammu. The specification of motors required to be repaired has been mentioned in the enclosed list forming Annexure "A".

The tenders complete in all respects and addressed to Deputy Director, State Motor Garages Department, New Plots, Jammu should reach in this office by or before 08.01.2017 upto 1600 hours. The opening date shall be notified separately.

Terms and Conditions:-


01. The rates of required jobs shall have to be quoted both in words as well as in figures.
02. The Tenders should be delivered in the office of the undersigned against a proper receipt.
03. A CDR/FDR amounting to Rs.500/- pledged to Deputy Director, State Motor Garages Department, Jammu shall have to be enclosed with the Tender. However, Government agencies are exempted from such security.
04. The tenders with cutting or over writings will be rejected.
05. The jobs executed should bear a warranty for a period of one year and during the warranty period if any defect in the executed job is found, the same shall have to be replaced/repared free of cost. The workmanship must be of high standard.
06. Incentive for Local Registered SSI units, as per Government Policy shall be allowed.
07. The successful tenderer shall have to execute the assigned job within a time limit specified in the work order.
08. In case the successful tenderer fails to rectify the defect within the stipulated time, the department shall be at liberty to make the arrangement of the needed item from 2nd lowest tenderer and the difference of cost incurred thereof shall be recovered from the defaulting tenderer.
09. The approved rates shall remain valid for a period of one year from the date of placement of first work order.
10. 100% payment shall be made on receipt of supplies & verified bills by Regional Inspection Committee of State Motor Garages Department, Jammu.
11. The Divisional Level Purchase Committee reserves to itself the right of accepting or rejecting any or all tenders without assigning any reason thereof.
