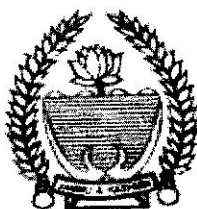

Tender document along-with terms and conditions of e-NIT and other documents can be downloaded from this office official website www.jksmg.gov.in and www.jktenders.gov.in. The tender shall have to upload scan copy of all necessary documents like CDR/FDR, tax clearance certificate, , trade certificate, tin certificate if any, The copy of ARAI certificate & copy of approval of State Transport Authority J&K (Motor Vehicle Department) of the vehicle (s). The original tender document/technical bid shall be submitted in a single sealed envelope superscribed as tender for supply of "Mahindra Make of Vehicles"

Terms and Conditions of the e-tender:-

The tender shall comprise of two bid system.

- I) Technical bid.
- II) Financial bid.

Technical Bid:-

The technical bid duly sealed in an envelope shall contain the following:-

- a) CDR/FDR for an amount of Rs.2.00 Lacs pledged to Accounts Officer, State Motor Garages Department, J&K Government.

- b) Tax clearance certificate form Income Tax Department for last two assessment years.
- c) An undertaking to the effect that the rates offered if approved by the State Level Purchase Committee shall remain in force for six months from the date of execution of agreement.
- d) Copy of certificate if registered as an SSI unit. SSI unit holders shall furnish the CDR/FDR as required under rules.
- e) Trade Certificate
- f) The copy of ARAI certificate & copy of approval of State Transport Authority J&K (Motor Vehicle Department) of the vehicle (s)
- g) TIN number if any.

Financial Bid:-

The "Financial Bid" is required to be uploaded on line as per the Bill of Quantities (BOQ) of e-NIT.

Other Terms and Conditions of e-tender:-




- 1) The hard copy of tender document should be properly sealed in an envelope duly marked as tender for supply of "Mahindra Make of Vehicles" addressed to Directorate of State Motor Garages Department, New Plots Jammu.
- 2) In case of any breach of the agreement at any time on the part of the tenderer, the agreement shall be terminated summarily by the Department and a penalty of 2% of the total cost of ordered vehicle(s) shall be imposed on the supplier and CDR/FDR shall be forfeited.
- 3) Disputes if any shall be settled by the Courts within the jurisdiction of J&K State (Srinagar/Jammu).
- 4) No tender will be considered unless and until all the documents are properly signed.
- 5) During the period of contract if the price of the ordered vehicle (s) decrease during the period of delivery the decreased price shall be considered as final.
- 6) Financial bid of only those tenderer shall be opened who will qualify the technical bid.
- 7) The supplier has to supply the vehicle (s) as per the specifications of the supply order and technical expert nominated by Deputy Director, State Motor Garages Department, Jammu/Kashmir shall be final to accept the deliveries of vehicle(s) after Pre-Delivery Inspection done.
- 8) The Department shall be at liberty to procure vehicle(s) in minimum quantity as per requirement within 4-6 weeks (including holidays). In case of exigency the vehicle(s) shall be supplied within the shortest possible time failing which the Department shall approach L-2 bidder after obtaining non-availability certificate from L-1 bidder.
- 9) Guarantee/Warranty period of vehicle(s) wherever applicable be specified and for such vehicle(s), in case of detection of any defect during the said period the items shall have to be replaced free of cost by the successful tenderer.
- 10) **Rates shall be quoted FOR destination i.e. Jammu/Srinagar and should be including temporary registration charges. However, any tax variation shall be applicable at the time of delivery of vehicle(s).**
- 11) No interest shall be paid on CDR/FDR and the FDR/CDR of the successful tenderer shall be converted into security deposit and those of unsuccessful tenderer shall be returned immediately after completion of the tendering process.
- 12) Any postal delay shall not be responsibility of the Department.
- 13) No terms and conditions of the tenderer shall be entertained by the Department.

Handwritten signatures and initials at the bottom of the page, including a signature that appears to be 'Om' and another that appears to be 'R'.

- 14) The successful tenderer has to sign the contract on terms and conditions of the contract referred to in the tender from "**Annexure-B**" to this notice.
- 15) The Chairman State Level Purchase Committee can stop the process at any time and can exercise options whatsoever, in the interest of the Government
- 16) Chairman State Level Purchase Committee reserves the right to accept or reject any tender at any time without assigning any reason thereof.



