03. The tender along with the samples shall be delivered in the office of the undersigned against the proper receipt.
04. The percentage of VAT and any other Taxes shall have to be mentioned separately.
05. No quotation with cutting overwriting shall be entertained/ accepted.
06. The tender items shall bear a warranty of sole crack/minor repairs for a period of at least one year, if defect found during the period, the supplier shall have to repair the Same without any extra charges.
07. The approved rates of the successful tenderers shall remain in force at least for a Period of one year and it will be binding on part of successful tenderer to supply the material without any failure during the period as and when orders are placed with him.
