
SHORT TERM TENDER NOTICE .

The Tenders shall be addressed to the Deputy Director, State Motor Garages Department Kashmir Bemina by-pass Road Srinagar and shall reach to this office by or before **28.11.2013 up to 2.00** PM and will be opened on 02.12.2013 at 11.00 AM in presence of tenderers who wish to be present at that time.

Terms and conditions.

- 1 The tenders should be accompanied with CDR/FDR of Rs.5000/= pledged to Deputy Director, State Motor Garages Department, Kashmir, No Cheque/Demand Draft will be accepted.
- 2 Rates with FOR shall be mentioned both in figures as well as in words with legible hand written or type writer.
- 3 The tender along-with the samples shall be delivered in the office of the undersigned against the proper receipt.
- 4 The percentage of Tax/Vat shall have to be mentioned separately.
- 5 No quotation with cutting over writings shall be entertained or accepted.
- 6 The tendered items shall bear a warranty of sole crack/minor repairs for a period of at least one year, if defect found during the period, the supplier shall have to repair the same without any extra charges
- 7 The approved rates of the successful tenderer shall remain in force at least for a period of one year and it will be binding on part of successful tenderer to supply the material without any failure during the period as and when orders are placed with him.
- 8 100% payment will be made after receipt of supply and proper inspection by Regional Inspection Committee of this Department.
- 9 The tenders shall be accompanied with VAT/TAX clearance certificate from the concerned Department.
- 10 The Divisional Purchase Committee reserves the right to accept or reject any or all tenders without assigning the reasons thereof.
