- ii) Matriculation/Date of Birth Certificate.
- iii) Health Certificate from the concerned Chief Medical Officer of the District.
- iv) Domicile Certificate issued by the Competent Authority.
- v) Valid relevant Category Certificate, if any applicable.
- vi) Valid HGV/PSV Driving License.

The appointment of the above candidates shall further be subject to the following conditions:-

- a) Each appointee shall give an undertaking in the shape of an affidavit as per Annexure-A to this Order to the effect that if on verification, his Qualification / Date of Birth / Domicile / Driving License / Reserved Category Certificates from the concerned issuing authorities is found fake / forged and if it is found that he possess lower/higher qualification than the prescribed one at any stage, his appointment as Driver Grade-II in the State Motor Garages Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b) That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- c) The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of genuineness of Qualification / Date of Birth / Domicile / Driving License / Reserved Category Certificates is received from the concerned Authorities/Agency.
- d) The appointees shall be on probation for a period of two years.
- e) The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f) The inter-se-seniority of the appointees in the State Motor Garages Department shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

g) The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
