Terms and Conditions for e-Auction of Condemned Vehicles / Un-serviceable Stores.

1. The interested bidders shall have to deposit an amount of ₹ 100000/= (*Rupees One Lac Only*) in the shape of CDR / FDR only pledged to the *Deputy Director, State Motor Garages Department Kashmir* as a security deposit within the period mentioned in the e-Auction Notice and submit the same in original to the Directorate of State Motor Garages Department J&K Srinagar / Jammu before participating in the Auction proceedings.
2. *The condemned vehicles mentioned in the e-Auction Notice shall be auctioned as Scrap interms of Notification No. GSR 653 (E) dated 23.09.2021, No. GSR 845 (E) dated 24.11.2022 & Office Memorandum No. RT-23013/8/2022-T dated 17.12.2022 issued by the Ministry of Road Transport & Highways and no auctioned vehicle(s) shall be transferrable in any case.*
3. The CDR / FDR, however shall be released to the unsuccessful bidder(s) as soon as the Auction proceedings are closed and to the successful bidders after the fulfillment of all the following conditions:-
 - a) The successful bidder(s) shall lift the auctioned vehicle(s) / material after depositing full payment including GST / other taxes as applicable under rules in the office of *Deputy Director State Motor Garages Department Kashmir*.
 - b) The successful bidder(s) shall submit scrap certificate in the office of *Deputy Director State Motor Garages Department Kashmir* to the effect that the auctioned vehicle(s) has been scrapped by him / them in presence of the constituted technical committee of this Department.
4. **The successful bidder shall have to deposit full payment including GST / other taxes as applicable under rules & shall lift the auctioned vehicles / material within 10 days from the date of acceptance of the bid on the GeM Portal.**
5. **In case the successful bidder fails to deposit the full payment including GST / other taxes as applicable under rules or fails to lift the auctioned vehicles / material within the stipulated period, the security deposit shall be forfeited without giving any reason / notice.**
6. GST / any other taxes applicable under rules shall have to be paid extra over the final bid amount by the successful bidder.
7. The Auctioned Vehicles / material shall be handed over to the successful bidder by the *Deputy Director, State Motor Garages Department Kashmir* upon receipt of full payment including GST / other taxes as applicable under rules.
8. The State Motor Garages Department shall not be responsible for any damage caused to the Auctioned Vehicle(s) or Material occurring due to natural calamities, fire, theft, etc.
9. The bidders desirous to participate in the Forward Auction on the GeM Portal (e-Auction) can inspect the vehicle(s) or Material at the notified locations.
10. The Vehicle(s) and material, intended to be auctioned through Forward Auction on the GeM Portal (e-Auction) is on **'as is where is'** basis, and the State Motor Garages Department shall presume that the interested bidder(s) have inspected the Vehicle(s) or Material and satisfied himself/themselves fully about the Vehicle(s) or Material which he/they intend to buy through Forward Auction on the GeM Portal (e-Auction).
11. The Auction Committee reserves the right of accepting or rejecting any bid without assigning any reason thereof and the decision of the Chairman shall be final.
12. The bidders desirous to participate in the Forward Auction on the GeM Portal (e-Auction) shall upload CDR/FDR and their particulars on the GeM Portal viz. Name of the Firm, Complete Postal Address, email ID, GST & PAN copy.
13. Other Terms and Conditions as envisaged by the GeM Portal shall be part of the Terms and conditions.
