For and on behalf of the Governor of J&K State e-tender is invited from the manufacturers/authorized distributors/suppliers of leather garments for supply of **Leather Jackets Sheep skin "A" Grade (Antic)** as per detail mentioned in Bill of Quantity (BOQ) to this notice.

The tenderer shall have to upload scanned copies of all necessary documents like CDR/FDR/TDR, SSI unit certificate, Pan card, GST No/Tin Certificate. The original tender document/ technical bid shall be submitted in a single sealed envelop superscribed as "Tender for supply of Leather Jackets" Sheep skin "A" Grade (Antic).

Terms & Conditions of the e-tender

The tender shall comprise of two bid system.

- i. Technical Bid.
- ii. Financial bid.

Technical Bid:

Technical bid duly sealed in an envelope shall contain the following:-


- a/ CDR/FDR for an amount of Rs.40000/- pledged to Accounts Officer State Motor Garages Department J&K Government.
- b/ **An under taking to the effect that the rates offered by the tenderers shall remain in force for one year from the date of issuance of first supply order.**
- c/ Copy of certificate if registered as an SSI unit. SSI unit holders shall furnish the CDR/FDR as applicable under rules.
- d/ GST No/TIN number as applicable.
- e/ Sample as per Specification given above be sent to the Directorate of SMG New Plots Jammu

Financial Bid:

The "Financial Bid" is required to be uploaded on line as per the Bill of Quantities (BOQ) of e-NIT.

Other Terms & Conditions of Tender:-

- 1) The hard copy of tender document should be properly sealed in the envelope and duly marked as tender for supply of Leather Jackets Sheep skin "A" Grade (Antic) addressed to Directorate State Motor Garages Department New Plots Jammu.
- 2) The successful tenderer shall have to take measurements of the employees individual-wise both at Kashmir and Jammu and shall have to supply the Jackets as per size of each individual.
- 3) The successful tenderer shall have to execute an agreement with the department within 7 days from the date of issuance of supply order as per the standard agreement form of Jammu and Kashmir Government. The firm shall also send attested copy of the supply order with the agreement to the Directorate of Sate Motor Garages Department J&K, with stamp duty of Rs.100/-.
- 4) In case of breach of whole or any part of the agreement at any time from the successful tenderer, the agreement shall be terminated summarily by the Department and a penalty of 2% of the total cost of ordered Leather Jacket (s) shall be imposed on the supplier and CDR/FDR shall be forfeited.



- 5) Disputes if any, shall be settled by the Courts within the jurisdiction of J&K State (Srinagar/Jammu).
- 6) No tender will be considered unless and until all the documents are properly signed.
- 7) **During the period of contract if the price of the material of the ordered item (s) decreases during the period of delivery the decreased price shall be considered as final.**
- 8) Financial bid of only those tenderer (s) shall be opened who will qualify the technical bid.
- 9) The supplier has to supply the Leather Jacket (s) manufactured after 1st January 2017.
- 10) *Guarantee/Warranty period of Leather Jacket (s) be specified and in case of any defect is detected during the said period the item (s) shall have to be replaced free of cost by the successful tenderer.*
- 11) *In case the first successful tenderer fails to supply the ordered material within the prescribed time the same shall be procured from the 1st lowest tenderer and difference cost shall be deducted from the First successful tenderer.*
- 12) **Rates shall be quoted FOR Jammu/Srinagar and should be inclusive of all taxes.**
- 13) Any postal delay shall not be responsibility of the department.
- 14) No terms and conditions of the tenderer shall be entertained by the Department.
- 15) Chairman, State Level Purchase Committee reserves the right to accept or reject any tender at any time without assigning any reason thereof.
- 16) The successful tenderer has to sign the contract of terms and conditions as mentioned in the tender form **Annexure "B"** to this notice.
- 17) 100% payment shall be released after receipt of material/items duly verified by the inspection committee.
