Subject: Appointment of Mr. Mehraj-d-din Yousuf, S/o Mohammad Yousuf Najar, R/o Narakara Budgam against the post of Helper under Open Merit in State Motor Garages Department, State Cadre.

Whereas, the Class-IV posts of Helpers, Cleaners, Chowkidars and Safaiwalas were advertised vide this office notice No:RCD-886/Oct-2010/4621-50/DSMG dated 19.10.2010 and subsequently re-advertised vide No:RCD-886/4388-4408 dated 4.10.2012;

Whereas, the interview of the shortlisted candidates was held on 26<sup>th</sup> to 28<sup>th</sup> December 2016 for Kashmir & Leh Ladakh based candidates and w.e.f 16<sup>th</sup> to 18<sup>th</sup> January 2017 for candidates of Jammu Division;

Whereas, on the basis of overall merit i.e academic as well as interview points, the selection list of the candidates for the post of Helper, Cleaner, Chowkidar and Safaiwala were notified by this office vide No:RCD-886/1395/DSMG dated 14.06.2017;

Whereas, among others one Showkat Ahmad S/o Mohammad Amin Sheikh R/o Devbugh Kunzar Baramulla was selected as Helper under OM category, but he conveyed his unwillingness to join in the State Motor Garages Department through application alongwith affidavit duly attested by Ist Class Magistrate;

Whereas, consequent upon non-joining of aforesaid candidate one Mr. Bilala Ahmad S/o Bashir Ahmad Lone R/o Devbugh Kunzar Baramulla figuring at serial No:1 in the waiting list was twice asked vide No:RCD-886/2267/DSMG dated 31.7.2017 and Final notice No:RCD-886/2667/DSMG dated 22.8.2017 to report to this office for appointment against the resultant vacancy of Helper, but he failed to report to this office within the stipulated time frame;

Whereas, as per the selection list issued by this office vide No:RCD-886/2017/DSMG dated 14.6.2017, you are figuring at serial No:2 in the waiting list for the post of Helper under Open Merit category;

Now, therefore through the medium of this Notice, you are advised to report to the Directorate of State Motor Garages Department Bemina Bye Pass Road Srinagar within a period of 15 days from the date of publication of this notice for submission of requisite documents against aforesaid vacancy, failing which it shall be presumed that you are not interested to join in this department against the post of Helper and your selection shall be deemed to have been canceled forthwith without any further notice.
