Subject: Cancellation of Selection of Mr. Mushtaq Ahmad Sofi S/o Ghulam Mohi -ud din Sofi R/o Nowhar Pulwama against the post of Helper/Cleaner under Open Merit category in State Motor Garages Department, (State Cadre).

Whereas, Class-IV posts of Helpers, Cleaners, Chowkidars and Safaiwalas were advertised vide this office No:RCD-886/Oct-2010/4621-50/DSMG dated 19.10.2010 and subsequently re-advertised vide No:RCD-886/4388-4408 dated 4.10.2012;

Whereas, the interview of the shortlisted candidates was held on 26th to 28th December 2016 for Kashmir & Leh Ladakh based candidates and w.e.f 16th to 18th January 2017 for candidates of Jammu Division;

Whereas, on the basis of overall merit viz. academic as well as interview points the selection list of the candidates for the post of Helper, Cleaner, Chowkidar and Safaiwala was notified by this office vide No:RCD-886/1395/DSMG dated 14.06.2017;

Whereas, one Mushtaq Ahmad Sofi S/o Gh Mohi- u- din R/o Nowhar Pulwama among others was selected as Helper and Cleaner in this department under Open Merit category, but the final recommendation in his favour was kept with-held by the selection committee subject to production of equivalence certificate of Matric Pass from JKBOSE;

Whereas, in response to the aforesaid notice, he submitted his original documents/certificates for his appointment in the State Motor Garages Department as Helper/Cleaner under OM Category;


Whereas, Matric Mark sheet and Qualification certificate submitted by Mr. Mushtaq Ahmad Sofi S/o Gh Mohi u din R/o Nowhar Pulwama were forwarded to J&K Board of School Education vide this office letter No:RCD-311/2214/DSMG dated 16.1.2014 for clarification, as to whether the said certificate is equivalent to Matric pass certificate in J&K or otherwise;

Whereas, Director Academics J&K State Board of School Education has intimated vide letter No:F(Acad-C)F.Eq/17 dated 17.8.2017 that the name of **Central Board of Higher Education New Delhi** neither exists in the list of member Boards of Council of Boards of School Education in India, nor in the list of other recognized Boards of the country. He has further added that the equivalence for any of the examinations conducted by the Central Board of Higher Education New Delhi cannot be granted by Council of Boards of School Education in India (COBSE).

Now, therefore, in view of above facts, selection of Mr. Mushtaq Ahmad Sofi S/o Ghulam Mohi ud din Sofi R/o Nowhar Pulwama for the post of Helper/Cleaner in the State Motor Garages Department is hereby cancelled forthwith.
